 - (b) Have sufficient knowledge of the applicant to warrant that they know the applicant
 - (c) Will vouch (certify, attest, witness, testify to the truth or genuineness) of the applicant as a very good and safe shooter.
2. **Member** has been defined as being the member, their spouse, and any children under the age of 18, living at home, (and any grandchildren, under the age of 18, whether living with the member or not). If children (including grandchildren) are present, they must be under the direct supervision of the parent or grandparent member, who has met the application requirements for membership, and who must not be shooting
3. The range is a closed range to the public. It is available to **members only**. Other than his or her minor children or spouse, a member must not bring guests on to the firing line or allow them to handle firearms at any time.
4. The application must be filled out completely and be accompanied with photo copies of the documents substantiating the applicant's training and background and be presented at a regular meeting. (Photocopies of documentation **MUST** clearly show the individual's name and all signatures, etc. Dark or light copies which do not show pertinent information cannot be accepted.) Please retain the Range Safety rules and caliber list which are attached to the application.

Please submit the following:

- Color copies of you and your spouse's Driver's License(s).
- Training Documentation (see page 2 of the application for examples)
- Application filled completely (pages 3 & 4)
- Membership Classification (page 4) form signed by applicant and their sponsor
- Liability Acknowledgements (pages 5-6) completely filled out, signed and witnessed.
- A check or money order (no cash please) made out to Delray Beach PBA (\$180.00 for Active membership or \$275.00 for Associate membership.)

Once submitted, your paperwork will be reviewed by the Board of Directors. Your sponsor will be notified of when you as the applicant can be presented before the membership at a regularly scheduled meeting.

DOCUMENTATION REQUIRED FOR MEMBERSHIP

(1) Color copies of Driver's licenses of applicant & applicant's spouse.

(2) TRAINING DOCUMENTATION REQUIRED FOR MEMBERSHIP

Any one of the following is an example of the documents which will be accepted for the training requirements of the applicant:

- ❖ A police officer either active or retired
- ❖ A notarized statement or document from a club, organization, school training facility or certified instructor showing that individual has completed a course or class or is and experienced competitor.
- ❖ A photocopy of your military honorable discharge document or photocopy of your DD-214.
- ❖ A photocopy of a certificate bearing the name of the organization, school or facility who sponsored the course or class and which includes the instructor's name and category of certification (NRA, State, etc.)
- ❖ A photocopy of your NRA competitor's classification card or similar documentation.
- ❖ A photocopy of a firearms instructor's certification card or certificate.
- ❖ A photocopy of any NRA firearms training certificate.
- ❖ A photocopy of a certificate or card showing completion of a hunter education or safety course approved by the Florida Fish and Wildlife Conservation Commission or similar agency of another state.
- ❖ A color photo copy of permit or license to carry concealed weapon or firearm issued in Florida.

- SOCIAL:** Persons elected to social membership shall not be eligible to vote or hold office, but shall be dues paying. They shall not have access to club facilities but may take part in social activities of the association.

RANGE SAFETY RULES
(DON'T BE SORRY, BE CAREFUL)

- ◆ DUE TO LIABILITY CONSIDERATIONS, ALL MEMBERS AND SPECTATORS MUST SIGN IN (DATE AND TIME) UPON ARRIVAL AND OUT AT TIME OF DEPARTURE. SIGNING SIGNIFIES ACCEPTANCE OF THE DBPBA “HOLD HARMLESS” AGREEMENTS CONTAINED IN THE SIGN IN BOOK.
- ◆ FIRST MEMBER ON THE RANGE IS THE RANGE SAFETY OFFICER (RSO), AND MEMBERS MUST OBEY THE RSO – NO EXCEPTIONS. THE RSO MAY RELINQUISH RANGE SAFETY OFFICER DUTIES TO ANOTHER MEMBER. IF PRESENT, CERTIFIED RANGE SAFETY OFFICERS (CRSO) MAY TAKE OVER RANGE SAFETY OFFICER DUTIES AT ANY TIME.
- ◆ EYE AND EAR PROTECTION MUST BE ON WHILE RANGE IS IN USE.
- ◆ PROPER ATTIRE IS MANDATORY; NO OPEN SHOES OR TANK TOPS.
- ◆ NO SMOKING, NO FOOD OR DRINK ALLOWED ON RANGE DUE TO THE DANGER OF LEAD CONTAMINATION.
- ◆ LOADED FIREARMS ARE ONLY PERMITTED ON RANGE FIRING LINE AND ONLY WHEN ALLOWED BY THE RSO.
- ◆ ONLY PAPER TARGETS AND BALLOONS ARE PERMITTED.
- ◆ BE SURE YOU USE ONLY ALLOWED AMMUNITION SIZES. (SEE LIST)
- ◆ LOAD THE RIGHT SIZE AMMUNITION AND ONLY WHEN READY TO FIRE.
- ◆ ALL LOADED FIREARMS MUST BE POINTED DOWN RANGE.
- ◆ THE SOUND OF A BELL, WHISTLE, OR RANGE SAFETY OFFICER CALLING CEASE FIRE MEANS STOP SHOOTING.
CEASE FIRE MEANS: STOP SHOOTING IMMEDIATELY, UNLOAD ALL AMMUNITION FROM FIREARM, AND OPEN CYLINDERS AND LOCK BACK SLIDES. REMOVE MAGAZINES AND LAY FIREARM ON TABLE. FIREARM MUST BE POINTED DOWN RANGE!
- ◆ NEVER LAY A LOADED FIREARM DOWN. UNLOAD IT BEFORE LAYING IT DOWN.
- ◆ UNCONTROLLED RAPID FIRE IS NOT PERMITTED.
- ◆ IF A MALFUNCTION OCCURS, KEEP MUZZLE POINTED DOWN RANGE AND HOLD HAND UP TO NOTIFY RANGE SAFETY OFFICER IF IT CAN'T BE CLEARED.
- ◆ CLEAN UP WHEN FINISHED AND DISPOSE OF SWEEPING IN THE APPROPRIATE BARRELS.
- ◆ BE CERTAIN THE SIDE DOOR IS CLOSED AND LOCKED AT ALL TIMES.
